

Candidacy Assessment Unit (CAU)

CAU Officer:

- Interview with families and youth
- Verifies family information, living situation and school enrollment
- DNA and Mugshot if needed
- Re-evaluate Risk/Needs Assessment-YLS/CMI
- Work with families and youth to develop an individualized Title IV-E Case Plan and determine candidacy.
- Seek input from the family to develop objectives to meet their individual needs
- Refer to POP Coordinator to link to services to address the identified areas of need
- Build upon family strengths
- Goal is to reduce out of home placements and to keep the youth and their families intact and reduce juvenile detention

CAU Case Assigner:

- Assigns walk-ins and no-show cases to CAU Officers
- Ensure all case plans meet Title IV-E requirements
- Confirms all assigned cases are linked to services

Probation Officer Program Coordinator (POP Coordinator)

- Assess each individual case and gather pertinent information (Intake, SSR, IEP, School records, medical insurance, etc.)
- Re-evaluate YLS/CMI
- Exchange information with CAU officer
- If there are any Mental Health concerns, consult with JJDTP for possible referral
- Identify any needs that may require services related to trauma
- Conduct face to face interview with parent and youth to explain interventions offered
- Tailor an intervention plan with youth and family
- Collaborate with Stanford Youth Solutions for assessment and entry into JJIS or Access services
- Refer families to services based on the YLS/CMI identified areas of need
- Staff cases bi-weekly with the DPO and service providers to recognize challenges, successes or needs for additional services
