Overview

On May 1, 2014, the Community Corrections Partnership (CCP) unanimously approved a Long Term Public Safety Realignment Plan (Plan) which provides a guiding framework document that outlines the goals and objectives of the CCP and County implementation of programs and services under Assembly Bills (AB) 109 and 117. With the acceptance of the Plan by the Board of Supervisors today, the County Executive's Office and the Board of Supervisors will be able to allocate AB 109/117 state funding in Fiscal Year 2014-15 and future fiscal years as part of the budget process.

Recommendation

Adopt the attached Resolution accepting the CCP's Long Term Public Safety Realignment Plan.

Measures/Evaluation

The Plan uses evidence based practices, research and data driven decisions to implement, develop, measure and evaluate the programs/services and processes used to address this offender population.

Fiscal Impact

The Plan will allow the County Executive's Office and the Board of Supervisors to make annual allocations of AB 109/117 funding received by the State to County departments as part of the budget process for Fiscal Year 2014-15 and in future years.

BACKGROUND

Chapters in 2011, AB 109 and AB 117, as amended, shifted the responsibility for managing offenders from the State to Counties. This public safety realignment was effective October 1, 2011. It is achieved by sentencing changes which prevent non-violent, non-serious and non-sex offenders from being sentenced to prison and by allowing defendants to be housed in the local jail for more than one year with time being served in jail, on probation or with alternative

custody options. Furthermore, offenders released from prison that have a current non-violent, non-serious conviction, or are a low to moderate risk sex offender will be sent to counties for local supervision.

The CCP, by statute, is responsible for developing a public safety realignment Implementation Plan to describe how this new population of offenders will be addressed in Sacramento County. Since October 1, 2011, the CCP has held public meetings with county departments, community based providers, non-profit organizations, educational institutes and members of the public to develop an annual Implementation Plan and to monitor the implemented programs. Going into Fiscal Year 2014-15, public safety realignment enters the fourth year of implementation in which core programs and services have been developed and implemented. The CCP has now developed and unanimously approved a Long Term Implementation Plan that will allow the County to maintain public safety and appropriately address the needs of AB109 offenders utilizing the authorized AB 109/117 funding without the need to approve an annual Plan. This will allow the County Executive's Office and Board of Supervisors to make funding allocations as part of the annual budget process, consistent with the framework outlined in the Long Term Plan.

DISCUSSION

For Fiscal Years 2011-12, 2012-13 and 2013-14 the CCP approved annual public safety realignment plans which outlined programs and services to be implemented and funded by AB 109/117 with each Plan being accepted by the Board of Supervisors. Initial caseload projections from the California Department of Corrections and Rehabilitation (CDCR) anticipated that it would take four years for full implementation to occur. With this in mind, the CCP felt that the core programs and services had been fully implemented thus far and that they could move forward with a Long Term Plan that would encompass what had been accomplished to date and provide the guiding framework for moving forward in Fiscal Year 2014-15 and future years. The Plan explains how Sacramento County will continue to manage the new class of offenders now under its responsibility.

The CCP held two public meetings on April 30 and May 1, 2014, to discuss, deliberate and approve the Plan. Comments were received from CCP members, departmental staff and members of the public which were incorporated into the document. The Plan recommends continued funding of the core programs and services as follows:

- Sheriff's Department in custody housing and inmate program/services
- Sheriff's Department Pretrial Release Program
- Sheriff's Department Home Detention/Electronic Monitoring Program (an alternative to incarceration) for community supervision
- Sheriff's Correctional Health funding for medical and mental health treatment/services/medication
- Probation's Adult Day Reporting Center Intake and Operations for community supervision
- Probation's Intensive Field Supervision and Gang Unit for community supervision
- Probation's medical and mental health treatment/services/medication
- District Attorney crime lab and prosecutorial staff augmentation
- Department of Human Assistance transitional housing with wrap around services

- Department of Human Assistance eligibility workers for benefit services for inmates and probationers
- Crime Data Collection and Analysis

Each rehabilitative program/service, incarceration and community supervision strategy is concerned with maintaining public safety, increasing treatment support for high-risk offenders and improving offender success rates for community reentry and reducing recidivism. The Plan is guided by research and data to implement the most cost-effective, evidence based practices that reduce recidivism, victimization and probation failure. As Plan recommendations are implemented, the CCP will report outcomes and program progress. Policies, practices and services will be assessed and evaluated to determine their effectiveness. The Plan encompasses programs and services provided directly by County departments, non-profits, treatment providers, community and faith-based providers, local law enforcement, employment and education partners all working together collaboratively to provide a comprehensive, systemic and sustainable approach for public safety realignment implementation.

MEASURES/EVALUATION

The Plan will use research and evidence based practices to implement, develop, measure and evaluate the programs, services and processes used to address this population.

FINANCIAL ANALYSIS

The Long Term Public Safety Realignment Plan will allow the County Executive's Office and the Board of Supervisors to make annual allocations of AB 109/117 funding received by the State to County departments as part of the budget process for Fiscal Year 2014-15 and in future years, consistent with the framework provided in the Plan.
