April 21, 2021

CALL TO ORDER: The meeting convened via Zoom video conference at 9:30 a.m. Commissioner Dennis Dulay welcomed participants.

Standing Committee Reports:

- ACPO Maria Gonzalez went over the YDF population report. There are currently no positive COVID cases at YDF.
- YDF is looking at possibly opening another unit and is discussing how staffing would work if this change is implemented.
- Chief Seale has resigned and ACPO Marlon Yarber will be the interim Chief.

Report from the Court:

- Judge Borack shared that in looking at the process of how to select the new Chief of Probation it seems that the applicant will be nominated by the JJC as directed by a majority of judges of the Court.
- Judge Borack also shared that on June 1, 2021, the Juvenile Justice Division will be reducing their courtrooms from four to three. Department 92 will no longer have a full time bench officer.
- Judge Borack also shared that at this time there is no certain date as to when the court will be reopened, but she will keep the Commission informed with any updates.

Standing Committee Reports Continued:

- Inspections: Commissioner Jane Claar shared that all Commissioners will be fully vaccinated after May 15 and can begin scheduling inspections.
