# Policy:

The Probation S-7 Security Classification is to be used to identify any youth within the Juvenile Correctional Health facilities who has a serious, chronic or acute medical condition, which requires special housing or handling. The decision of whether or not a resident is classified an S-7 will be determined by the Nursing Supervisor and/or the Medical Doctor. After 23:00, and there is no Nursing Supervisor on duty, the Intake RN will contact the on-call Nursing Supervisor for direction.

#### **Procedures:**

- A. Identify S-7 residents when it is determined that the youth meets the criteria for S-7 status the Medical staff will fill out the appropriate Red S-7 Classification form and give it to the Probation Supervisor on duty for distribution and classification. The Medical Staff will, also add the youth's name to the Restriction List and check the S-7 box on that list.
  - 1. The Probation Unit Staff will be responsible for putting the Red Classification form in the youth's Juvenile Hall File, checking the restriction list daily and indicating the S-7 status on the Unit white board.
  - 2.Should the youth's medical condition improve and the Doctor determines that the S-7 status is no longer valid, the Medical staff will notify the Probation Supervisor and/or the Classification Officer to remove the S-7 Classification. The Red Classification form will then be updated by the Probation Staff to indicate removal from the S-Status.
  - 3. The S-7 Classification will follow the resident from one incarceration another until it is removed by a Medical Doctor.
