Commissioner Daniel Okada asked if interns could be utilized to assist with the presentation. Natalia stated there is a possibility of utilizing interns, but for her Community & Government Relations unit, not the G.I.F.T presentation.

Commissioner Rachel Rios asked how to support prevention efforts. Mike Shores stating addressing kids while at sites like Hickey and Gerber would be the best time to use this program as a preventative presentation.

Natalia Luna mentioned that there are several youth programs that will be rolling out in the near future. She stated that she would also like to expand the presentation process to include information on bullying and sexploitation, as well as other key issues.
