## SUMMARY OF MINUTES

June 20, 2017

1. **CALL TO ORDER:** A quorum was present, and the meeting was convened at 10:14 a.m.
  2. **APPROVAL OF MINUTES FROM THE FEBRUARY MEETING:** Commissioner Frederick Mills motioned to approve the May minutes; the motion was seconded by Commissioner Dennis Dulay. Commissioner Carole D'Elia abstained from voting. The minutes were approved.

  4. **PUBLIC COMMENTS:** None
  5. **PRESENTATION:** Anti-Recidivism Coalition (ARC) with Victor Malin and Daniel Silva. Victor briefly introduced himself and discussed his background and previous involvement within the system. Handouts of the presentation were given to all attendees.

Victor noted some issues plaguing the organization earlier on such as staffing cuts and the ability to get the youth to fully understand accountability. Recently ARC received additional funding through the California Endowment which is allowing them to hire new staff and expand their programming. Victor expressed his excitement to hire the new Administrative Assistant position that will provide the much needed support for the day to day operations.

Victor invited the Commission to come downtown and visit the ARC location and see firsthand the work they are doing. The location address is: 1414 K Street, Suite 150, Sacramento, CA 95814.

Judge Boulware-Eurie asked, given her position within the juvenile system, what more could be done to assist with the ARC population. Victor noted the re-entry component is significant and should really be invested in.

Commissioner Gwen Jackson asked if there has been any issues with the youth when filling out employment applications and having to provide the information of them being felons? Victor noted ARC has spoken with many employers and have already paved the way for youth applying.

6. **COMMENTS FROM PROBATION:** In regards to the previous discussion on LGBTQ youth, Chief Seale noted Santa Clara County would be training the Youth Detention Facility and Management on their current practices. The Chief expressed his desire to have Commissioner Virginia Maulfair present at the training if she is available.

Chief Seale noted Juvenile Field will be presenting on Title IV-E Waiver during the July meeting.
