Assistant Chief Probation Officer Julie Wherry provided a budget update regarding the need for extra funding for two additional housing units within Valley Oak Youth Academy (VOYA) due to the returning youth from the Division of Juvenile Justice (DJJ). With this increase in population, funding will also need to be allocated to administrative support, expansion of outreach and the re-entry unit. It is unknown at this time how many youths currently at DJJ will be committed to VOYA, alternative programs or released back into the community.
