3. CCPAB Ad Hoc AB109 Budget and Program Committee Report Back	Bill Pieper

The Ad Hoc group met the 9th of February. They identified the SIM as the best inventory of the program. Catherine York was asked to integrate it with AB109 plans that currently exist. This allows a person to cross reference the SIM with the plan to know what the partnership has. A recommendation was made to visit programs that contract AB109 funds to better inform the committee. LeeAnn McCluskey has offered an open invitation to visit the programs at any ADRC location. The group plans to move monthly meetings to twice a month.

5. Update on County American Rescue Plan Act (ARPA) Funding Decisions	Catherine York, CCP Analyst

Last month an update was requested on ARPA. March 11, 2021 the President signed the act and Sacramento County received \$301,469,072 which must be obligated by 12/31/24 and spent by 12/26/26. Allowable use includes: support COVID-19 public health and economic response, premium pay for eligible workers performing essential work, government services to the extent of lost public sector revenue, and invest in water, sewer, and broadband infrastructure. The County Board of Supervisors established three priority areas: Housing and Homelessness, Health, and Economic Response, with a total of 25 projects.

<ul style="list-style-type: none"> • An issue that has come up with the Sacramento Homeless Organizing Committee is if people who need assist have to be referred rather than accessing it personally. It seems a person would have to be arrested to get the treatment they seek. <ul style="list-style-type: none"> ○ The County is currently looking at ways that they can coordinate better as a system and finding alternatives to incarcerating. ○ Capacity is also an issue when providing services. ○ The County provides a broad range of services but it can be difficult to navigate to the different services. 211 is a resource to call to gain information on service needs. ○ The County just invested an alternative to 911 program, Wellness Crisis Call Center and Response, which will coordinate with law enforcement on calls and provide services. Catherine York can provide a summary from the Board on what the program will consist of. There are currently 9 Mobile Crisis Teams. <ul style="list-style-type: none"> ▪ Wellness Crisis Call Center and Response ○ Amy Holliday has read several reports from the Sheriff's Department that state a license therapist has been out on the calls. They are able to assess people and advise the deputy's what the person is going through. <p>Q: Is everyone interested in a presentation from the Sheriff's Department? A: Multiple members replied yes.</p> • Prepare Mental Health Professionals to work with justice involved individuals.
