3. SCOE Update	2:15 - 2:30	15 minutes	Jacqueline White
<p>SCOE provided a PDF document with an update to the VOYA education. The document is available on the DJJ Realignment website. Proposed a Certificate Pathway so that students can receive a certificate in a shorter period of time if they are unable to take classes long-term. The NCCT certification program is approximately one year. With prior experience, it can be less time. If students are in VOYA for a longer period of time, the goal would be to set up their 1st, 2nd, and 3rd choices. How best to maintain their skills over time will have to be researched. Youth will be surveyed to determine what the most popular interests are to engage in. SCOE is working on a pipe line for education for teachers. SCOE has paid opportunities for peer mentors. The position similar to the service coordinator is located at the school site. This community based person coordinates services for youth at the site.</p>			
4. Re-Entry Planning Follow Up	2:30 - 3:00	30 minutes	JJCC Subcommittee Members
<p>Discussion relative to how long will it take community service individual to line up housing and jobs for youth. It was stated that Probation Re-Entry team has been working hard on ensuring services are provided. It would be helpful to know what services and resources are available to Probation. Now might be a good time to invite the Re-Entry team for a presentation. Probation currently is working on finalizing a contract for two beds. Freedom through Education and Exodus also provide housing and ARC have referred some youth as well.</p>			
5. ACTION ITEM: JJCC Subcommittee Public Member Vacancy	3:00 - 3:15	15 minutes	Marlon Yarber, Chair
<p>The suggestion is to take a similar process as before to fill the current vacancy by advertising the seat, talk about the role of the JJCC Subcommittee, and then go through an application process. An added piece to the process would be a recommendation to the JJCC and their approval. The last application process was approximately three weeks but was requested to be extended. Recommendation to put together a description of the requirements. Comments focusing the community member seat with someone with a background from housing or victim advocate. Last selection process included members of the subcommittee reviewing applications. There was not an interview process. No action required today on this item.</p>
